#### DIRECTIONS

#### As a spot cleaner on rubber tire marks:

Dilute Skid-Daddle 1:1 with water and spray or pour directly on the marks. Allow the solution to soften the tire mark for at least 15 minutes and then scrub the area. Rinse well with clean water.

#### As a bucket cleaner:

Skid-Daddle is a blend of special cleaning agents, Dilute Skid-Daddle 20:1 to 50:1 with water depending on

Rinse well. Completely remove Skid-Daddle from the surface of the substrate.

#### CLEANUP

#### STORAGE

Store in tightly sealed containers in a cool dry area away from direct sunlight and sources of heat. Shelf life of properly stored material is two years from date of manufacture.

#### LIMITATIONS

· A test area is recommended. This is especially important if the exact chemistry of the floor sealer or coating is unknown. Apply Skid-Daddle diluted 1:1 with water to a 1ft<sup>2</sup>(0.3m<sup>2</sup>) area and scrub. If any deterioration of the coating or sealer is noticed or if the surface loses its sheen contact ChemMasters' Technical Service Department for alternative recommendations.
